For issuance of SLC, all dues must be cleared till August.

Fee payment regulations:

- ❖ **The School fee is payable up to 5th of every month.** In case of non-payment of fee, after the date of 15th every month SR: 100/-, fine will be charged for each student and for each month. Monthly fee including VAT must be paid by the 15th of each month without any exception.
- ❖ In case, the default continues for three months, the name of the student will be struck off. The student can be re-admitted after paying all dues, re-admission fee of SR: 300/-, and fine of SR: 200/- along with a written application addressed to the Principal. However, the re-admission will be entirely on the discretion of the Principal with the recommendation of Coordinator and availability of seats.
- ❖ Submission for CAIE Cambridge Exams fee for IGCSE/AS Levels and Checkpoints is due in the month of January of each calendar year.
- ❖ Deposit of full fee (12 Months) is obligatory for obtaining the School Final Term Exams Results as well as CIE Exams (Checkpoints/IGCSE/AS Levels) Results. Parents are advised to plan their payments accordingly.

❖ Fee payments due time for obtaining SOEs / Results of CIE(Checkpoints/IGCSE/AS levels):

- SOEs -Statements of entry (enrollment forms) for the **Checkpoints Exams** are distributed usually in the month of March/April with respect to the school fee clearance for the month of March/April respectively.
- SOEs -Statements of entry for the IGCSE/AS level **CIE Exams May-June series** are distributed usually in the month of March/April with respect to the school fee clearance for the month of June.
- CIE Results of IGCSE/AS levels/Checkpoints are declared usually in the month of July/August and are provided with respect to the school fee clearance for the month of August.

Please be informed that:

- *The aforementioned due timings are tentative and can be revised following the due dates from Cambridge with prior notice.*
- *The Final Term Results of Grade 6,8 students are provided to the students in the month of July/August after adding the percentage of Checkpoint Results.*

❖ **Fee Counter will continue to function during summer vacation.**

In order to avoid payment of late fine, please deposit the dues of your ward(s) in time.

Parents should ensure that an official 'Fee Receipt' is immediately obtained from the School fee counter for any payment.

There is no any other source of fee deposit except School Fee Counter/Bank Account.
